

**收集個人資料聲明（「本聲明」）**  
**美聯物業(商舖)有限公司（「本公司」）**

1. 為達至本公司能提供地產代理服務的目的，閣下可能被要求提供閣下的個人資料予本公司，而該等個人資料包括但不限於姓名、聯絡資料（包括但不限於電話號碼、傳真號碼、電郵及／或通訊地址）、身份證明文件號碼及可能載有閣下的個人資料的文件副本，例如身份證、護照、銀行月結單及公用事業賬單。
2. 提供個人資料純屬自願性質，若閣下未能提供該等個人資料，本公司可能因此而未能提供地產代理服務。
3. 閣下所提供的個人資料可能被本公司用於以下用途：
  - (a) 提供地產代理服務；
  - (b) 直接促銷本公司之地產代理服務；
  - (c) 轉移至下列第 6 條所列之機構或人士（「第三方」）用於直接促銷與下述第 5(a)條促銷標的的類別有關之服務、獎賞及／或優惠計劃及／或活動（「該等服務」）；
  - (d) 遵守適用法律、規則及規例，以及由監管機構所發出並適用於本公司的指引、執業通告、操守守則及執業指引；
  - (e) 收取欠款；及／或

4. 使用個人資料作直接促銷

**Personal Information Collection Statement (“PICS”)  
Midland Realty (Shops) Ltd. (the “Company”)**

1. You may be required to supply the Company with personal data for the provision of real estate agency services by the Company, and such personal data may include but not limited to the name, contact details (including but not limited to telephone number, fax number, email and/or correspondence address), identification document number and copy of any document which may contain your personal data, such as identity card, passport, bank statements and utility bills.
2. Provision of personal data is on a voluntary basis. Failure to supply such personal data may result in the Company being unable to provide real estate agency services.
3. The personal data provided by you may be used by the Company for the purpose of:
  - (a) provision of real estate agency services;
  - (b) direct marketing of the real estate agency services of the Company;
  - (c) direct marketing of the services, reward and/or promotional programmes and/or events provided by the institutions or individuals listed in paragraph 6 below (the “Third Parties”) in relation to the classes of marketing subjects specified in paragraph 5(a) below (the “Services”);
  - (d) compliance with the applicable laws, rules and regulations as well as the guidelines, practice circulars, code of ethics and practice directions issued by the regulatory authorities and applicable to the Company;
  - (e) collection of outstanding debts; and/or
  - (f) legal proceedings and/or enforcement of judgments and/or orders.
4. Use of Personal Data for Direct Marketing
  - (a) The Company intends to use your name and contact details (including telephone number, fax number, email and/or correspondence address) for direct marketing of the real estate agency services of the Company.
  - (b) Unless we have obtained your consent, the Company cannot use your personal data for direct marketing. Therefore, if you object to the aforesaid use of your personal data for direct marketing by the Company, please tick “✓” in the box below and initial next to it.  
 You (name stated below) object to the aforesaid use of your personal data for direct marketing by the Company.
5. Transfer of Personal Data for Direct Marketing

Therefore, if you agree to the aforesaid transfer of your personal data by the Company to the Third Parties, please sign at the end of the PICS. However, if you object to this, please tick “✓” in the box below and initial next to it.  
 You (name stated below) object to the aforesaid transfer of your personal data by the Company to the Third Parties for use in direct marketing in relation to the Services marked “#” that you have deleted and initial next to it under paragraph 5(a) above.
6. Your personal data held by the Company may be transferred to the following parties:
  - (a) co-operative estate agents;
  - (b) service providers of the Company offering rewards and/or promotions;
  - (c) law firms, banks, financial institutions, insurers, service providers for mortgage referral, financial planning, property valuation, immigration consultancy and/or wealth management;
  - (d) government agencies, regulatory bodies and/or other lawful authorities;
  - (e) courts, tribunals and/or parties to the legal proceedings; and/or
  - (f) debt collection agencies.
7. When you visit the Company’s website, the Company’s webserver makes a record of your visit that includes your source IP address, access time, URL, browser type and your device type (webserver access log). The Company uses the webserver access log for the purpose of maintaining and improving the Company’s website such as to determine the optimal screen resolution, which pages have been most frequently visited etc. The Company does not use, and has no intention to use the visitor data to personally identify anyone. Most web browsers are initially set up to accept cookies. You have a choice not to accept the cookies, but if you do, certain functionality may not be available.
8. Pursuant to Personal Data (Privacy) Ordinance (Cap 486, Laws of Hong Kong), even if you have given consent to the Company on the use and/or transfer to the Third Parties of your personal data for direct marketing, you still have the right, at any time without charge, to request the Company to cease to use and/or transfer your personal data to the Third Parties for direct marketing. You may also request to access and/or correct your personal data. You may at any time write to the Data Protection Officer of the Company at [dpo@midlandici.com.hk](mailto:dpo@midlandici.com.hk) or Rooms 2505-8, 25/F, World-Wide House, 19 Des Voeux Road Central, Hong Kong. Under the said Ordinance, the Company has the right to charge a reasonable fee for the processing of your data access and/or correction request.
